The LD3 Board meetings have been held via Zoom since 2022 and the former LD3 Chair called to order 4 Board meetings via Zoom in December therefore *customary practice has been established*.

According to Robert's Rules of Order (RONR) 12th edition - *Custom 2:25 "In some organizations, a particular practice may sometimes come to be followed as a matter of established custom so that it is treated practically as if it were prescribed by a rule."*

If Zoom meetings are invalid as the former LD3 Chair claims, then...

**WHY** didn't she make the announcement *PRIOR* to the start of the Board meeting?

**WHY** did she call the Board meeting to order if it was invalid?

**WHY** did she wait until half-way through the Board meeting until *AFTER* the vote to have the Special Meeting on 12/28/22 passed to make her announcement?

The facts are that ***Zoom meetings have been accepted as standard practice*** and the former LD3 Chair did **NOT** want a Special Meeting for the PCs to vote to have a re-election of Officers and State Committeemen for fear she would not get re-elected.
