1. The Bob Gomez Board is the recognized board of LD3 by the Maricopa County Republican Committee (MCRC). The MCRC approved a re-election of the LD3 Executive Board. They just cleaned up what Mickie Niland, the previous Chair of MCRC, left undone. Mickie Niland supported a re-election, but forcibly with threats to the existing board to have it delayed due to the holidays. Mickie, however, did not have a problem with LD11 having their election during the holidays. Mickie never followed up to make sure it happened. Her intervention is backed up by emails. She supports Czarny as she is extremely biased. This is proven by Mickie choosing to attend the meetings of the Czarny Club and her emails.
2. The AZGOP Chair, Jeff DeWit, has openly indicated that the Czarny Club is the official board of LD3. Per bylaws, Jeff has no power to enforce this. He has sent his opinion not only to all the PCs of LD3, but has tried to influence the judge in the current lawsuit that Czarny has filed against MCRC. He has not responded to requests by Chair Gomez to have a meeting or phone conversation.
3. Three of the Bob Gomez Board, Carol Torkko, Michelle Rugloski, and Bob Gomez, actively helped campaign for the GOP winners in the August, 2022 election for Arizona State government offices. Bob donated and solicited donations and purchased backpacks for the PCs to use to carry materials from door-to-door. Michelle called for a joint meeting of PCs in the northern precincts in LD3 to form various committees to phone call voters, door knocking, put up campaign signs, etc. In 3 months, the PCs on those committees knocked on 18, 417 doors, made 7,238 phone calls, and put up over 300 campaign signs. This was all because the current board of LD3 headed by Rich Rutkowski, Nancy Ordowski and Debbie Trudeau did nothing as they did not support the Trump endorsed candidates that won in the August primary. All three of them are strong supporters of the Czarny Club. The LD3 Board complained that Michelle had done this without their involvement. They could have done the same thing for the precincts on the southern end of LD3, but chose to do nothing.
4. The Bob Gomez Board and supporters are for “We the People”. In other words, we will campaign and support any GOP candidate that wins in the primaries and Presidential Preference Election (PPE). We strongly believe in what the people want even if the candidates we want do not win in the primaries. The Czarny Club does not support this principle as shown in #3 above.
5. Bob Gomez Board and supporters are definitely not in favor of the “establishment” controlling this country. We are definitely in favor of cleaning the swamp, which is what Trump supports. A lot of evidence has been brought out in the lawsuit trial that shows how the Rich Rutkowski board pushed and supported for Czarny to be elected as Chair in the December 1st election using practices that violated the bylaws and the rules of the meeting. The Czarny Club supports the establishment and wants for themselves to be in power that they have had for a very long time.
6. The MCRC Resolution, that Jeff DeWit chose not to support, would have setup the PPE in March next year to be a one-day vote within a precinct, paper ballots and hand-counting. This would have been only for the vote for President in the Republican Party. Jeff has indicated that he supports election integrity. This was his chance to prove it. He said that the deadline to inform the Secretary of State was too quick to make a decision. He backed this up by saying that it would have disenfranchised voters that could not vote and that there would be lawsuits and that the election process would be extremely costly. Can he seriously believe that we are that stupid on his phony excuses?
 - a. All who are unable or choose not to vote in person can request an absentee ballot with ID and their signature. They are vetted up front and if they are approved, will receive their ballot through the mail - NO DISENFRANCHIZEMENT or LAWSUITS. It would be significantly cheaper than the postage and printing for massive mail-in ballots and all the time for validating all those mail-in ballots.
 - b. There is no need to have a separate voting location for each precinct. It would be reasonable to combine precincts into one location, such as a school gym. The cost to do this for ONE DAY is far cheaper than now as we would not be paying for multiple days and weeks for voting locations. The number of locations does not need to be more than is

used today. Voting within your precinct does NOT mean that the voting location for the precinct has to be within the precinct itself.

- c. Only one position is on the ballot. So, even in the largest precincts, it would not take more than two to three hours to count the ballots by candidate.
7. Bob Gomez Board and Body censured Jeff DeWit as result of #6 above and his actions in trying to interfere in the Czarny lawsuit case, and his poor performance in fund raising, etc.
8. Czarny Club has setup tribunals to punish all PCs that are not in her favor. This includes all of the Bob Gomez Board and many others. If she should win her lawsuit, we will be banished from attending any LD3 meetings and events for the remainder of our term, which is October 1, 2024. Our PC rights to vote and participate in meetings would be stripped from us. We have letters and emails to prove it. This is all because we are doing the job we were elected to do. Forget about freedom of speech. Talk about who is destroying the Republican Party.
9. Compare our set of bylaws versus the Czarny Club set of bylaws. We have eliminated the use of proxies, where as they still allow one proxy per attendee.
10. Bob Gomez Board and supporters have censured Joseph Chaplik for his role in Liz Harris being expelled as a State Legislator. Czarny Club supported the expulsion of Liz Harris as indicated in her emails to all of us.
11. Bob Gomez Board has recently emailed and sent letters to all PCs that did not attend District meetings from the time the LD3 was formed in March, 2022 through September, 2022. We have asked them to contact us. Given no contact, we have plans to remove them as PCs. We are looking to eliminate invalid and inactive PCs in preparation to have PCs that plan to be active in helping us. This is not intending to destroy the Republican Party. If anything, it is intended to make us stronger.
12. Bob Gomez Board strongly believes in free speech, but is not supported as shown in #8 above by the Czarny Club.
13. Bob Gomez Board strongly supports election integrity, where Czarny Club does not seem to as shown in #6 above.
14. Refer to #3 above to see how the Bob Gomez supporters supported the GOP candidates in 2022 and Czarny supporters did not.
15. The Bob Gomez Board and supporters have passed a resolution supporting the winner of the PPE in March and that includes Trump. We also support all the facets of election integrity that Trump has been promoting.
16. Refer to the Call Letters for Bob Gomez's meetings and the Czarny's meetings. Bob Gomez encourages guests AND recording of any meeting whereas Czarny does not allow guests and recordings by individual PCs.
17. Bob Gomez Board has proven many times that we want what the PCs want. The Czarny Club does not. They want to be in total control at all times.
18. Bob Gomez has encouraged for PCs to get to know each other prior and after the meeting. The Czarny Club has indicated in their Call Letter that no conversation is to take place in the meeting room even prior to the start of the meeting.
19. We have requested from the start to have a complete audit of all proxies submitted in the December 1st election. This would include the ability to contact the witnesses. That has not happened. They say the election was fair, but does not want it to be thoroughly verified. In the recent proxy audit, we were not even allowed to touch the proxies.
20. Czarny in her emails is accusing Chairman Craig Berland of MCRC of not approving new PC applications that she has approved. She is absolutely right. Craig is following the bylaws. She does NOT have the right to approve those applications. The MCRC has sent them to Bob Gomez for approval. Some have been approved and some are still waiting as the BOS has not approved any applications for eight weeks. That is out of all of our control.
