

The following was researched and provided by some of our LD3 PC's interested in providing TRUTH. They have requested we provide to the Body. Freedom of speech is important!!!

There appears to be a concerted effort by a few members of the past LD3 Board to mislead the LD3 PCs.

We want to make sure everyone has all the facts and evidence to make an informed decision. For that reason, we have provided the following information for you to look over and consider.

LD3 PC's for TRUTH.

1. **FACT:** The former Chair of LD3 has never allowed an audit of the ballots and proxies from the December 1, 2022, elections.

TRUTH: On 12/4/22, the LD3 Board filed an official "Timely Challenge" with the MCRC per the MCRC Bylaws Article II Section 4F, Timely Challenge to "*resolve by conducting a hand recount of the officer election at our recent organizational meeting. Including a canvass or verification of proxies submitted to the credentials committee.*" (See the Timely Challenge below)

TRUTH: On Thursday February 9, 2023, the Maricopa County Chair delivered through the First Vice-Chair a letter stating that *Ballots, Credentials, and Proxy documents from the Legislative District 3 December 1, 2022, election be turned over to the custody of the County to perform an audit and canvas. The former LD3 Chair refused to turn over the documents to the MCRC.* (See the letter below)

TRUTH: On Tuesday, March 7, 2023, The Maricopa County Republican Committee (MCRC) and the Executive Guidance Council (EGC - the LD Chairs) voted 19 Yes and 7 No (2 Abstained) for LD3 to have a new election administered by the MCRC. In another majority vote, the MCRC EGC formally censured the former LD3 Chair and demanded the resignation over **multiple Bylaw violations as well as refusal to cooperate with an audit and canvas of the LD3 December 1, 2022, Election.** (See the censure below)

2. FACT: The former Chair was spending money without an approved budget.

TRUTH: On 2/19/23 the board held a meeting to approve the items that were purchased PRIOR to the 2/19/23 board meeting. (see the Board Meeting Minutes and the receipt below)

3. FACT: The former Chair excluded the LD3 Treasurer from the bank account for a period of time when checks were being written without his signature.

TRUTH: The LD3 Treasurer was removed from the LD3 bank account **WITHOUT** his knowledge. *The former MCRC 2nd Vice Chair explains why they removed the Treasurer because they did NOT want him to have access to the District funds to pay for the venue for the LD3 Special Meeting that was to be held on 12/28/22.* (See the video and audio below)

4. FACT: The former Chair stopped the re-election of the board on Dec 28th after the board approved it.

TRUTH: On 12/17/22 the Board held a duly sanctioned emergency meeting to vote on having a credentialed Special Meeting to be held on 12/28/22 for the PCs to vote to redo the Officers and State Committeemen election. **The vote passed by majority to have the sanctioned Special meeting on 12/28/22.** (See the board meeting minutes and meeting audio below)

TRUTH: On 12/20/22 the former Chair of LD3 sent an “important December 20 update” to all the LD3 PCs. **“ATTENTION The Dec 28th meeting is NOT a sanctioned meeting. Bylaws were not adhered to in the calling of this meeting. ATTENDANCE IS NOT REQUIRED OR ENCOURAGED.”** (see the email below)

TRUTH: On 12/27/22 the former Chair of LD3 sent an email to all the PCs in LD3 to invalidate the 12/28/22 Special election and to discourage PCs from attending the meeting. (See the video below)

5. **FACT:** The former chair of LD3 did not report the actions of the board meetings to the body per bylaws.

TRUTH: At the 1/12/23 LD3 meeting **after** the Chairman’s Report a PC made a Point of Order asking the former Chair to give the PCs a report of the **four** December board meetings. The 1/12/23 meeting minutes **do NOT include the reports from the four December Board Meetings by the former Chair.** (See the board meeting minutes below)

6. **FACT:** The former Chair of LD3 continues to misrepresent herself as the chair of LD3. However, the MCRC recognizes the officers elected on 3/30/23 by the body of PCs, with 146 PCs in person and 50 PCs present by proxy for a total of 196 votes.

TRUTH: [The AZGOP has no jurisdiction over precinct committeemen. The Legislative Districts work in cooperation with the MCRC.](#) **Bylaws Article II – Members, Section**

4. The MCRC website lists all the current Legislative District Chairman, the former Chair is NOT listed on the website. (see the MCRC website below)

7. **FACT:** The former chair failed to cooperate with the MCRC per LD3 bylaws.

TRUTH: The former Chair of LD3 violated The MCRC Bylaws Article II – Members, Section 4 – District Chairman #3 which states: “Cooperate with the MCRC Chairman” AND the LD3 Bylaws Article IV – ELECTED OFFICERS, Section 3. District Chairman #6 “Cooperating with the Maricopa County Republican Committee Chairman...” (see the censure below)

8. **FACT:** The former Chair did not allow motions from the floor at a District Meeting.

TRUTH: The video from the 1/12/23 LD3 meeting shows the former Chair told PCs they were “Out of Order” for making a motion, for calling for a Parliamentary Inquiry, and for calling for a Point of Order. The former Chair also, did NOT follow Roberts Rules of Order. (see video below)
